Please take note of the following regulations that you should agree to before submitting your recommendations and testimonies (hereinafter together called "comments"):

1. In order to submit comments to us, you must be both above the age of majority and gainfully employed according to legislation in your home country. You should guarantee that you devised formulation of the comment yourself and that no one else has any right to the comment you submit. You give a specific undertaking and guarantee that submitting your comment for purposes outlined in these conditions does not infringe copyright in any way.
2. Upon submission of the comment to us, you grant us unremunerated, permanent, irrevocable and global authorisation to use your comment. The right of use granted to us in this way is unlimited and encompasses particularly the right to duplicate and publish on our websites and in print media, and the comment may be sub-licensed to others, particularly to companies associated with us in line with § 15 AktG (German Companies Act).
3. You also grant us the right to adapt your comment, provided this adaptation does not alter the objectively identifiable meaning. Adaptation in this sense mostly consists of abbreviation of the comment.
4. We have the right to delete the comment if it contravenes governing law, if third parties request that we delete it and if in our judgement deletion is either sensible or necessary. We may delete your comments, if you contravene these conditions of use.
